GENERAL

- **AgraActivator™ 12** is a fertilizer with macro- and micro- nutrients for crops, pot plants, ornamental shrubs, lawn, vegetables, and fruit trees grown in hydroponic systems or standard cultivation practices.
- Foliar spraying should preferably be done during the cooler periods of the day (ideal 20 °C; < 25 °C), as well as when the relative humidity is on its highest.
- Do not apply to plants when plants are wilted or under abiotic stress.

COMPATIBILITY

- Always verify compatibility with other Agricultural products by doing a miscibility test.
- Combinations with Ca or Ca-based products should be avoided.

Fertigation application 1-2 g/L (Lower rate is recommended when frequent applications are made)	Apply every 1-2 weeks from emergence until the flowering growth stage of the plant. Do not exceed the nutrient requirements of the plant (as advised by an agronomist based on soil and/or leaf analysis).
Crops, pot plants, ornamental shrubs, lawn, fruit trees and vegetables	Foliar application 10-20 g/L (1-2% solution; lower rate is recommended when frequent applications are made)	Apply every 1-2 weeks from the vegetative growth stage to flowering stage. Do not exceed nutrient requirement of the plant (based on soil and/or leaf analysis)
