GENERAL

- For optimum results apply AgraAlgen according to recommendations.

DIRECTIONS FOR USE

- Premix the prescribed amount of AgraAlgen in water and mix thoroughly before application to spray tank. Ensure thorough mixing before and during application. For best results, do not let prepared mixture stand overnight. Apply to foliage in adequate spray volume to ensure good crop coverage.

METHOD OF APPLICATION

Crop	Time of application	Application rate
Maize seed application	Before planting	20 mg/kg seed (dissolve in 10 ml water/kg seed)
Grain crops	3-5 leaf stage	250 g/ha
Vegetables	3-5 leaf stage	250 g/ha
