Vegetable crops	Via dripper irrigation system 10-100 kg/ha	Apply from 3 leaf stage and repeat application as required (at least 1-2 weeks apart) based on soil and/or leaf analysis. Do not exceed nutrient requirement of the crop.
Fruit Tree crops	Via dripper irrigation system 10-100 kg/ha	Apply every 1-2 weeks during season as required based on soil and/or leaf analysis. Do not exceed nutrient requirement of the crop.
